Subject: **Connect Systems - Member Eligibility Coverage Group Classifications**

Dear Provider,

This notice is being sent to all CT Behavioral Health Partnership (CT BHP) Providers regarding upcoming enhancements to the Administrative Service Organization's (ASO) Connect systems. *Please note that the following notice is for informational purposes only.* The upcoming enhancements will **not** affect authorization/registration procedures and it will **not** affect billing procedures.

Effective October 1<sup>st</sup>, 2011, the CT BHP ASO will re-classify some of the current DSS member benefit groups. System changes are required to ensure that membership/enrollment/benefit structures are in synchronization with the state's requirements from an enrollment and claims payment perspective. Additionally, these updates will allow the ASO to better serve our state client and provider community with all reporting initiatives.

The re-classification of coverage groups in the CT BHP Connect system will be as follows:

1. BHK001 (HUSKYA), BHK008 (FSS DUAL) AND BHK012 (FSS SINGLE) will become inactive.
2. BHK013 (FAMILY SINGLE), BHK014 (FAMILY DUAL), BHK015 (ABD/OTHER SINGLE) and BHK016 (ABD/OTHER DUAL) will be added and used for the new coverage groups.

*Please note: Providers are still required to verify client eligibility through any of the current HP ([www.ctdssmap](http://www.ctdssmap)) eligibility verification methods. The CT BHP Connect systems should not be used to verify Medicaid eligibility. This notice is for informational purposes only. The above changes will **not** affect authorization procedures and it will **not** affect billing procedures.*
